INVITATION TO TENDER

Grounds Maintenance Contracts in Bramerton

Bramerton Parish Council wishes to appoint a contractor(s) to carry out grass cutting (two sites in the village) and hedge cutting (three sites in village).

Tenders are invited for the work as detailed below:

TENDER 1 - GRASS CUTTING

<u>Area 1 – Bramerton Recreation Ground</u>

To mow the grass and strim the areas on Bramerton Recreation Ground, and the children's play area, at Easthill Lane, Bramerton, Norwich, NR14 7QE as shown in Figure 1. It is expected that this site will be cut once a fortnight during the period 1st April to 31st October 2024, but as an exception this may vary depending on the weather.

Area 2 - Grass cutting, Bramerton Common

To mow the grass and strim the areas on Bramerton Common, Mill Hill, Bramerton, Norwich, NR14 7EN as show in Figure 2. It is expected that this site will be cut once a fortnight during the period 1st April to 31st October 2023, but as an exception this may vary depending on the weather.

Tenders for Tender 1 should state the overall cost for the 2024 season, based on each of the 3 sites being cut once a fortnight during the period 1st April to 31st October 2024, and should also quote per cut for each area, as number of cuts may vary depending on the weather.

TENDER 2 - GRASS CUTTING

To cut the grass on Bramerton allotments and community orchard at Hill House Road, Bramerton, Norwich, NR14 7EE as shown in Figure 3. Pathways (shown in pink) and grass for a metre around each tree in the community orchard are to be cut once a fortnight during the period 1st April to 31st October 2024, but as an exception this may vary depending on the weather. The rest of the grass in the community orchard and the grass in the wild meadow is to be cut twice year at times to be mutually agreed.

TENDER 3 - HEDGE & VEGETATION CUTTING

Annual hedge and vegetation cutting at the following three locations to the specification as shown on Figure 4. Hedge and vegetation cutting must avoid the nesting season (1st March to 31st August).

- i. Bramerton Allotments, Hill House Road, Bramerton, Norwich, NR14 7EE.
- ii. Bramerton Recreation Ground, East Hill Lane, Bramerton, Norwich, NR14 7QE.
- iii. Bramerton Common, Mill Hill, Bramerton, Norwich, NR14 7EN

Please refer to attached hedge & vegetation cutting plan. Figure 4.

Tenders for hedge and vegetation cutting should quote price per cut.

Tenders should be submitted in **writing** in a sealed envelope, clearly marked "Grounds Maintenance" on the outside, addressed to:


Please note bids will be considered for both tenders or for individual tenders should a contractor wish to do so.



Please note that no herbicides are to be used on any Parish Council land without express written instructions from the Parish Clerk.




